




With four out of the top ten universities globally, the third most unicorns, a thriving digital economy and vibrant startup ecosystem, the UK is a world leader in technology and innovation.

In 2020, \$15b was invested into British technology companies, more than France and Germany combined. This outstanding success has not translated to China, where British companies are underperforming versus their western counterparts.

A lack of market knowledge and exposure, fragmented ecosystem and an overreliance on American capital (and market) have caused this disconnect, hindering cross-border trade and investment in the sector.

For British companies to achieve their potential, this must change.





We established the Technology & Innovation Committee to enhance Sino-UK ties in the technology sector.

The Technology and Innovation Committee of the British Chamber of Commerce Shanghai is the first Sino-UK tech-focused platform in China that brings together industry leaders, government departments, and non-profit organisations.
