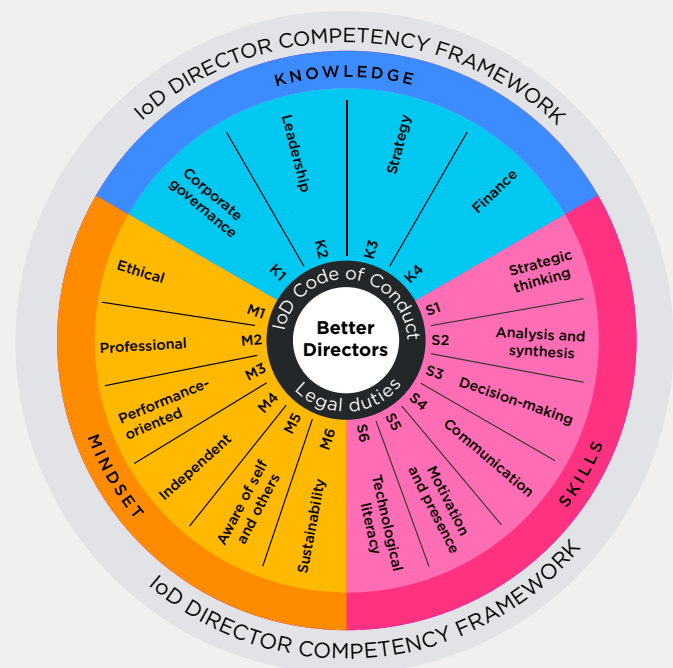

Director Competency Framework



Programme content

The first stage in our Chartered Director Programme equips you with the skills, knowledge and mindset needed to function as an effective director at board level. The certificate covers a wide range of topics including governance, finance, strategy and leadership. It has been SCQF credit rated by Qualifications Scotland.



International Role of the Director and the Board **13-14 October 2026** **British Consulate-General Shanghai**

This course gives you a practical understanding of best practice in the boardroom and the confidence to tackle boardroom challenges.

It introduces a director's duties and legal responsibilities and the board's role in corporate governance and risk management. It explains how to ensure internal procedures such as executive appointments and remuneration remain transparent.

Objectives

To give you the knowledge and skills to:

- understand the key duties, roles and legal responsibilities of the director
- identify the differences between direction, management and ownership
- develop strategies for delivering best practice in the boardroom

Benefits

- deliver your current strategic objectives while future-proofing your organisation

You will leave with practical, applicable knowledge to deliver your organisation's objectives, while anticipating risk and ensuring you're ready for the future.

Objectives

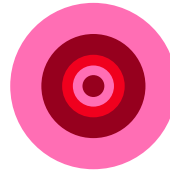
To give you the knowledge and skills to:

Leadership for Directors

18-19 October 2027

Shanghai

Objectives

To give you the knowledge and skills to:

- develop greater awareness of yourself and the motivations and behaviours of others
- create a culture that constructively engages others in the organisation to achieve its strategic objectives, and to respond effectively to crisis and change
- identify how leaders create influence and impact within and beyond the organisation and assess relevant stakeholder engagement strategies
